## **BOOTH OPTIONS**


#### STANDARD BOOTHS

There are two categories of booths as listed below.

**TYPE 1**: Consists of 6 panels each measuring 1 x 2 meters, one skirted table and two chairs. Additional furniture may be provided upon request as illustrated below.



**TYPE 2:** Consists of 3 panels each measuring 1 x 2 meters, one skirted table and two chairs.



The standard booths have the following specifications,

- Grey "velcro receptive" panels
- A header sign across the top of the middle panel which will be printed in block letters with the exhibitor name
- Two Spot Lights and a power source
- Free wireless internet

Larger booths can be assembled by combining a number of Type 1 booths for exhibitors wishing to secure more space.

#### **CUSTOM BOOTHS**

Exhibitors wishing to build custom exhibits may book unfurnished space.

Allocation of custom booths is subject to availability of space. Queries on custom space requests should be sent to the exhibition focal point via email before online registration takes place.

#### **EXHIBITION SCHEDULE**

- The exhibition will run from 15 to 19 April 2013 and will be open daily from 9:00 am to 6:00 pm.
- Exhibitors will set up their booths on 13 to 14
  April.
- Exhibitors will be required to dismantle displays from **4 pm**, **19 April to 20 April**.
- Exhibition Booths must be permanently manned during the forum.
