Organized by the Urban Legislation Unit, this event will provide a forum where mayors and representatives of local authorities can discuss their legislative needs. After an initial introduction on the work of the Urban Legislation Unit, the discussion of the participants will be guided by the findings of a survey conducted by the Unit. The survey provides basic information on the areas where local officials believe there are weaknesses in their regulatory systems, lack of capacities and need for reform. Habitat Agenda partners consultative forum

(conference room 9)

The Habitat Agenda partners consultative forum aims to explore how to strengthen partnerships with key Habitat Agenda partners, especially through enhancing civil society participation in policy dialogues; the design, implementation, monitoring and evaluation of urbanization and human settlements programmes; capacity-building; advocacy; and the fostering of accountability and aid effectiveness at the all levels.

Environmentally sustainable transport forum for Africa (conference room 10)

The hosts of the event will be the Africa Transport Policy Programme and the World Bank, in partnership with the United Nations Department of Economic and Social Affairs and the United Nations Centre for Regional Development. The event will provide a key African forum for high-level discussions on the interconnected areas of common interest of transport, environment, human health and human settlements. It will draw from the experiences of Regional environmentally sustainable transport programmes established in Asia and Latin America and will support Africa's participation in the discussions on sustainable transport in the post-2015 development agenda

New generation of national urban policies: what works and what doesn't (conference room 13)

Participants will discuss the urbanization process from a national policy perspective. Presentations will be made on case studies of countries in the North and the South on steps taken to address the challenges and opportunities presented by urbanization. Recent evolutions, based on evidence of how to articulate urbanization and economic development and poverty alleviation, will also be discussed, as will effective instruments that could be included in a new generation of national urban policies.

Achieving sustainable energy access for the urban poor (conference room 14)

The benefits of improving access to modern energy services in urban and peri-urban areas are transformational: lighting for productive activities, increased security, energy for basic service provision, including water and sanitation, cleaner indoor air, faster food-processing and cooking, more income-generating opportunities, industrial development and others. Energy is one essential factor in unlocking the productive potential of cities. Improving urban energy access must become one of the most important objectives in fighting poverty in the twenty-first century. Through dialogue and interaction, the stakeholders participating in this event

will discuss advances in achieving energy access for the urban poor.

Urbanization: catalyst for or impediment to women's empowerment? (conference room 11)

Participants at this event will discuss the linkages between urbanization and gender, specifically how women are positively affecting the urban landscape and how the urban landscape in turn facilitates or impedes women's and communities' empowerment. The main purpose of this event is to enable participants to deliberate on and understand how women worldwide are turning oppression into opportunity and the role that urbanization plays in the process.

Recycling project (conference room 14)

Inappropriate waste disposal is an issue for major urban centres. Participants will discuss a recycling initiative that is socially, environmentally and economically important to the modern world in thatit provides ways to improve health conditions, provide better and more affordable housing, increase the feeling of well–being in the neighbourhoods where the initiative is implemented and provides a source of income for recyclers.

Global Housing Strategy (conference room 9)

The UN-Habitat Global Housing Strategy is a collaborative global movement aimed at achieving adequate housing for all and improving the housing and living conditions of slum dwellers. Its main objective is to assist member States in working towards the realization of the right to adequate housing. The Strategy was initiated by the Governing Council in its resolution 23/16. To achieve the goal of adequate housing for all, the backbone of the Strategy will rely on the principles of inclusive cities as the sound foundations for sustainable urban development. Inclusive cities are achieved by mainstreaming human rights in urban development, including housing and slum upgrading, to ensure social integration, aiming for the elimination of the urban divide.

Innovative options for managing city drainage (conference room10)

This event provides a good opportunity to raise awareness among policy makers of the issue of drainage as well innovative solutions that can address the problem. Experts will present best practices, appropriate technologies and new sustainable applications and solutions, outlining cost effective, easily managed and resilient alternatives to conventional ways of managing urban drainage.

Securing land tenure in the context of women's empowerment (conference room 11) The objective of the event is to gather key partners of the Global Land Tool Network to discuss the initiative for improving women's access to economic opportunities, particularly with regard to acquiring land and property rights. The goal of this initiative on women's secure tenure is to create and promote a roadmap that will facilitate the development of policies and practices to improve women's secure tenure across the legislative, administrative and development sectors at all levels.

UN-Habitat's role in humanitarian affairs (conference room 13)

Post-disaster and post-conflict projects form a large proportion of the projects implemented by UN-Habitat in accordance with the policy approved by the Governing Council on human settlements in crisis. This policy, which articulates UN-Habitat's role with regard to human settlements and crisis, responds to resolution 20/17 and documents produced in response to resolution 19/9 in relation to post-conflict, natural and human-made disaster assessment and reconstruction. The event will highlight the progress made by UN-Habitat on these resolutions.

Promoting sustainable transport solutions for East African cities (conference room 14) The overall goal of this project is to create the technical and institutional basis for implementing metropolitan sustainable transport networks and systems and to establish a demonstration corridor for sustainable urban mobility. The project aims at reducing growth in

private motorized vehicles, thus reducing traffic congestion and greenhouse-gas emissions. The envisaged strategic plan is to upgrade transit systems, develop improved non-motorized transport infrastructure and apply travel demand management as well as other supporting policies.

Art and architecture at work in urban Africa (conference room 9)

Art and architecture at work, by focusing on the human being and culture within the city, offers a complement to UN Habitat's broad mission of tackling housing and urban growth on a grand scale. It advocates the inclusion of artists' and architects' visions in long-term urban planning processes. Artists and architects together bring significant input to the process of urban planning. Through public spaces, public art and public architecture, they can, alongside state-driven initiatives, engage civil society, with the aim of achieving cultural ownership of cities and steering urban growth towards sustainable and inclusive patterns.

City and urban prosperity indices (conference room 10)

This event, organized by the UN-Habitat Research Unit, will go a long way in demonstrating the concrete implications of UN-Habitat's vision, particularly with regard to moving forward with the post-2015 development agenda.

First regional steering committee meeting of the project "Promoting Energy Efficiency in Buildings in East Africa" (conference room 11)

The project "Promoting Energy Efficiency in Buildings in East Africa" was initiated by UN-Habitat in collaboration with the governments of Kenya, Uganda, the United Republic of Tanzania, Rwanda and Burundi and the United Nations Environment Programme. The five-year programme (2011–2015) is co-funded by Global Environment Facility and aims at mainstreaming energy efficiency measures into housing policies, building codes and building practices in East Africa.

The mission of APMCHUD is to promote sustainable housing and urban development for human settlements in the Asia-Pacific region.

Sustainable urban Development in Tanzania: participation of women and youth in the formalization of squatter settlements in Njombe Town, Morogoro Municipality and Arusha City (conference room 11)

Mkurubita is a property and business formalization programme conceived by the Government of the United Republic of Tanzania with the objective of creating a unified legal and institutional framework that recognizes secured and accessible property rights. The priority Mkurabita is to formalize property ownership in squatter settlements through a participatory approach.

Contribution of sustainable transport to the post-2015 development agenda (conference room 14)

This side event will provide information and promote discussion on the discussion on sustainable transport and the post-2015 development agenda, including possible sustainable development goals. The event is part of a wider set of consultations aimed at developing a common understanding of the contribution that sustainable transport can make to sustainable development. Various formulations of a sustainable development goal for sustainable transport have been discussed and proposed with varying levels of emphasis on the environmental, social and economic dimensions of sustainable transport.

Participatory slum upgrading programme (conference room 10)

UN-Habitat's participatory slum upgrading programme contributes to achieving goal 7 of the Millennium Development Goals (to ensure environmental sustainability), including the targets to halve, by 2015, the proportion of people without sustainable access to safe drinking water and basic sanitation and to achieve significant improvement in the lives of at least 100 million slum dwellers by 2020. The programme applies a human-rights-based approach, including the right to adequate housing and the right to basic urban services, a results-based management approach with regard to accountability and transparency, and a clear division of roles and tasks between programme stakeholders at the country level.

Achieving sustainable energy planning in cities in Africa and Asia (conference room 9) Sustainable energy planning takes into consideration demand and supply. Compact cities require less energy for their operation. Energy demand management is also critical as it mitigates climate change. Cities are often seen as consumers, but they have the potential to supply energy using renewable energy sources, including municipal liquid and solid waste. Smart and low-carbon cities integrate all the above. The Urban Energy Unit will host this event, at which stakeholders will discuss advances in achieving sustainable energy planning for cities in Africa.

Debate session on Habitat III (conference room 7)

World Urban Campaign partners will share their views on the forthcoming Habitat III conference and the Campaign's potential contribution as a global advocacy platform and think tank on sustainable urbanization.. The event will be hosted by the World Urban Campaign secretariat of UN-Habitat.
