Opening of the session

1. The twentieth session of the Governing Council will be opened at 10 a.m. on Monday, 4 April 2005 by the President of the Governing Council at its nineteenth session, or, in his absence, by one of the other officers of the Governing Council at its nineteenth session.

2. In accordance with rule 17 of its rules of procedure, the Governing Council will elect a President, three Vice-Presidents and a Rapporteur. The geographical distribution of officers elected at previous sessions of the Governing Council is shown in annex II below.

13. Annex III

Proposed organizational arrangements for the twentieth session of the Governing Council of UN-Habitat

Note by the Executive Director

1. The Governing Council may find it conducive to the efficient conduct of its work during the twentieth session to adopt the specific organizational arrangements set forth below.

A. Bureau

2. In accordance with rule 17 of the Governing Council's Rules of Procedure, the Bureau should consist of a President , three Vice- Presidents and a Rapporteur, elected with due regard to the principle of equitable geographical distribution and rotation among the groups. Annex II to the present notification shows the geographical distribution of members of the Bureau at previous sessions of the Governing Council.

3. As provided for in rule 18 of the Governing Council's Rules of Procedure, one of the Vice-Presidents should be designated to chair the sessional committee of the whole referred to in paragraph 16 below. The remaining two Vice-Presidents would assist the President of the Governing Council directly in his or her duties in plenary and chair the ad hoc drafting committee referred to in paragraph 17 below.

B. Plenary

4. Following consultations with the Bureau of the Governing Council, it is recommended that the plenary should divide its work into two segments: a high-level segment of ministers, heads of delegations and mayors, which would be held in plenary on the first and second day; and dialogues with local authorities and other partners, to be held on the third day.

C. The high-level segment (first segment of the plenary)

5. It is suggested that the high-level segment of ministers, heads of delegations and mayors should focus its discussions on the following three agenda items: activities of the United Nations Human Settlements Programme (UN-Habitat): progress report of the Executive Director (item 4 of the provisional agenda); work programme of UN-Habitat for the 2006–2007 biennium and budget of the United Nations Habitat and Human Settlements Foundation for the 2006–2007 biennium (item 9 of the provisional agenda); and implementing and monitoring the goal of the United Nations Millennium Declaration on improving the lives of slum dwellers (item 6 of the provisional agenda).

6. Secondly, and with a view to accommodating the 60 to 80 delegations which normally attend the sessions of the Governing Council, it is recommended that, during the high-level segment, each delegation should be allowed a maximum of five minutes' speaking time and that that limit should be strictly adhered to. In that connection, it should be noted that part of the morning session on the first day will be taken up by organizational matters.

7. In establishing the list of speakers for the high-level segment, precedence will be given to ministers and deputy ministers. Those will be followed by other heads of Government delegations and by Habitat Agenda partners.

D. Dialogues with local authorities and other partners (second segment of the plenary)

8. The two dialogues with local authorities and other partners will focus on recommendations on decentralization and the strengthening of local authorities (item 7 of the provisional agenda) and strengthening the United Nations Habitat and Human Settlements Foundation (item 8 of the provisional agenda).

9. In that connection, it should be recalled that, in operative paragraph 2 of its resolution 16/12, the Governing Council decided "to provide, at future sessions of the Governing Council, opportunities for partners to engage in a dialogue among themselves and with Governments; such dialogues may, as appropriate, serve as an input to the deliberations of the Governing Council".

10. In pursuance of the above decision, and with a view to increasing the participation and contribution of local authorities and other partners in the work of the Governing Council, arrangements have been made for dialogues with local authorities and other partners to be held in the plenary on the third day, as indicated in annex IV to the present notification. Those dialogues, which will be on the themes mentioned in paragraph 8 above, will be based on the format followed by Committee II at the Habitat II Conference in Istanbul, whereby representatives of partner groups will be given an opportunity to make a substantive presentation followed by a dialogue or discussion between Governments and partners on the presentations.

11. To that end, local authorities and other partners are encouraged to submit, in advance, a written summary of their presentations to the secretariat for distribution to all participants ahead of the meeting. They are also encouraged to include in their presentations specific issues of strategic importance to the implementation of the work programme of UN-Habitat for the biennium 2006–2007 (document HSP/GC/20/9).

12. It is expected that the presentations to be made by representatives of local authorities and other partners will be the result of a preparatory process (consultations) by those groups, including non-governmental organizations, parliamentarians and the private sector as well as professionals, researchers and labour unions. Arrangements will be made for local authorities and each group of partners to have, if they so wish, consultations in Nairobi immediately prior to the twentieth session of the Governing Council, or at any other time and venue of their choice.

13. Detailed information on the organization of the dialogues is given in annex VI to the present notification.

E. Summaries of the Chair

14. At the end of the high-level segment and the dialogues with local authorities and other partners, the Presidents, drawing from the deliberations in the two plenary segments, will prepare summaries of the main issues raised in the high-level segment and of the conclusions (or recommendations) made in the dialogues. The two summaries will reflect the main thrust of the discussions and the key positions stated during the two segments and will be submitted to plenary for endorsement.

15. Once endorsed by the Governing Council as an accurate reflection of the high-level segment and the dialogues with partners, the President's conclusions and recommendations will serve as guidelines for follow-up action by Governments, local authorities, other partners and the secretariat.

F. Sessional committee of the whole

16. Bearing in mind the organization of work in previous sessions of the Governing Council and the above recommendations on the work of the plenary, the Governing Council may find it advisable to establish a sessional committee of the whole which would be given the responsibility for items 5 (a), 5 (b), 6, 9, 10 and 11, with the remaining items being considered in plenary session.

G. Drafting committee

17. At the nineteenth session, on an informal basis, the Governing Council established an ad hoc open-ended drafting committee under the chairmanship of one of the Vice-Presidents to pre-screen draft resolutions submitted by delegations with a view to merging, reconciling or clarifying them, as necessary, before their consideration by the Governing Council. The Governing Council may wish to continue that practice, which was widely acknowledged to have enhanced the efficiency of its work.

H. Proposed timetable

18. For the ease of reference, a proposed timetable for the twentieth session of the Governing Council is provided in annex IV to the present notification.

19. A list of the agenda items for the twentieth session of the Governing Council, with corresponding documents, is provided in annex V to the present notification.

Annex VI

Dialogues with local authorities and other Habitat Agenda partners

Schedule

1. The two dialogues with local authorities and other Habitat Agenda partners will be held in plenary session on Wednesday, 6 April 2005 during the morning and afternoon meetings, as indicated in annex IV.

Format

2. The dialogues will be based on the innovative model launched at the Habitat II Conference and successfully revived at the seventeenth, eighteenth and nineteenth sessions of the Governing Council. Accordingly, the Executive Director and designated representatives of Governments, local authorities and other groups of Habitat Agenda partners will make short, substantive presentations followed by a discussion between delegations and panellists.

3. The two dialogues will be conducted as open discussions directly related to the themes of the dialogues. The discussions will be inclusive and substantive, and their results should be action-oriented. Delegations wishing to do so can, however, provide the secretariat with written statements, in 250 copies, which will be circulated and synthesized in the Presidents' summary to be endorsed by the Governing Council.

Expected results

4. The main purpose of the two dialogues is to present and discuss the planned contributions of Governments, local authorities and other Habitat Agenda partners to the implementation of the relevant sections of the Habitat Agenda and the UN-Habitat work programme and related outputs. Accordingly, panellists and delegates are invited to focus their interventions on both the conceptual and operational aspects of the two dialogue themes. Once adopted, the Presidents' conclusions and the recommendations of the dialogues will serve as guidelines for follow-up action by Governments, local authorities, other Habitat Agenda Partners and UN-Habitat itself.

Dialogue I: Effective decentralization and the strengthening of local authorities

(Wednesday, 6 April 2005; morning session)

5. In its resolution 19/12 of 9 May 2003, the Governing Council requested the Executive Director to take further steps and measures to intensify dialogue on decentralization and the strengthening of local authorities between Governments, local authorities and other Habitat Agenda partners, including through the Committee of Permanent Representatives to UN-Habitat, the Advisory Committee of Local Authorities and the second session of the World Urban Forum, with the aim of developing recommendations to be presented to the twentieth session of the Governing Council and documenting best practices. Resolution 19/12 further endorsed the proposal by the Executive Director to establish a multidisciplinary, ad hoc advisory panel on decentralization to support the dialogue process. It also requested the Executive Director to initiate efforts to mobilize additional extrabudgetary resources to enable the ad hoc advisory panel to perform its tasks.

6. The first step towards the implementation of resolution 19/12 was the establishment by UN-Habitat of an Advisory Group of Experts on Decentralization in Gatineau, Canada, on 9 and 10 March 2004 under the umbrella of the United Nations Advisory Committee of Local Authorities (UNACLA). UNACLA, which was established in January 2000 pursuant to resolution 17/18 to strengthen the international dialogue with local authorities on development issues, has been instrumental in raising the profile of local authorities at the international level. UNACLA members*

^{*} The membership of UNACLA comprises leading local-government representatives from across the world, including the leadership of the newly established United Cities and Local Governments (UCLG) organization. Its members are selected by the UN-Habitat Executive Director to ensure a geographical balance. Its current chair is Mr. Joan Clos, Mayor of Barcelona, Spain and President of Metropolis.

have actively participated in the dialogue process on decentralization for the last five years. The task of UNACLA task is to facilitate the dialogue between and among local authorities, national Governments and the United Nations system through a systematic and practical exchange on substantive issues which should contribute to strengthening the role of local authorities in international development and the promotion of democratic governance.

7. The inaugural meeting of Advisory Group of Experts on Decentralization was followed by a dialogue session on decentralization entitled "Urban Renaissance: Towards New Powers for Local Governments in a Globalizing World", which was held during the second session of the World Urban Forum in Barcelona, Spain from 13 to 17 September 2004. The dialogue session on "Urban Renaissance" put special emphasis on the linkages between urbanization and globalization on one hand and decentralization trends on the other. Given the rapid urbanization of the world and considering the impact of global trends on the lives of the citizens, an innovative strategy which empowers local communities to pursue global standards in harmony with local objectives is key to articulate the need for "more global and more local" interventions, all at one and the same time.

8. On 14 September 2004, the second meeting of the Advisory Group of Experts on Decentralization was convened in Barcelona to finalize the draft guidelines on decentralization and agree on the format of a compendium of best practices on decentralization, in line with resolution 19/12. The proposed guidelines are attached to report HSP/GC/20/7 on the implementation of resolution 19/12. A first draft of the compendium of best practices on decentralization, if available before the twentieth session of the Governing Council, may also be circulated to Council members as an information document.

9. Given the progress made in the implementation of resolution 19/12 and the overall work done by UN-Habitat on decentralization and the strengthening of local authorities, and considering the interest expressed by all Habitat Agenda partners in those activities together with the cooperation agreement between UN-Habitat and UCLG, a dialogue session on decentralization will be held as part of the official deliberations of the Governing Council under agenda item 7. The dialogue will provide a forum for a broader discussion of the principles outlined in the guidelines referred to in paragraph 4 above. Its main purpose will be to ascertain the views of Governments and make recommendations on the implementation of the proposed guidelines.

Dialogue II: Financing shelter and urban development

(Wednesday, 6 April 2005, afternoon session)

10. The second dialogue session will provide an opportunity for delegates to the twentieth session of the Governing Council to discuss the three key elements of financing shelter and urban development: the role of cities in subnational, national and regional economic development and how financing shelter and urban infrastructure can serve as strategic investment to accelerate economic growth; the challenge of improving donor coherence in financing shelter and urban development – which will involve consideration of the poverty reduction strategies and the country assistance strategies and their effectiveness in harmonizing the priorities of national Governments, multilateral financial institutions, multilateral development agencies and bilateral development cooperation agencies – and the role of domestic capital markets and financial instruments which can attract private investment for shelter and related urban infrastructure.

11. In addition to discussing those elements of financing human settlements, the dialogue will also serve as an opportunity for delegates to review progress to date on the forthcoming 2005 Global Report on Human Settlements entitled "Financing Human Settlements and Urban Development". A synthesis of the draft report will be made available to delegates before the twentieth session of the Governing Council.

12. The secretariat plans to invite as panellists for the dialogue accomplished academics, policymakers and practitioners who will share their experiences on financing shelter and urban development.
