Corrigendum

The following corrigendum relates to document HSP/GC/20/1/Add.1 entitled "Annotations to the Provisional Agenda, including Organization of Work". The proposals indicated in paragraphs 1-5 here below have been prepared at the request of the Committee of Permanent Representatives to UN-HABITAT, the inter-sessional subsidiary body of the Governing Council.

- 1. In paragraph 5 of Annex III entitled "Proposed Organizational arrangements for the twentieth session of the Governing Council of UN-HABITAT" which indicates the items which will be considered by the High-level segment of Plenary, the following words should be added at the end of the paragraph: "and Coordination matters (item 10 of the provisional agenda). This last agenda item includes the issues which will be considered by the thirteenth session of the Commission on Sustainable Development (New York; 11-22 April 2005)."
- 2. Consequently, and in Annex IV which contains the timetable for the schedule of meetings during the session, agenda item 10 should also be added after items "4, 6 and 9" which are indicated as the items to be discussed by the High-level segment in Plenary on Monday 4th April and on Tuesday 5 April .
- 3. In addition to the consideration of the issues before the Commission on Sustainable Development in plenary as indicated above, it should be noted that in paragraph 16 of Annex III and in the timetable indicated in Annex IV, the above-mentioned item 10 (which includes these same issues) will also be considered, in more detail, by the Committee of the Whole of the Governing Council on Thursday 7 April 2005 during the morning session. At the end of the consideration of this item in the Committee of the Whole and in Plenary, a Summary by the Chair reflecting the discussions on these particular issues will be prepared

for approval by the plenary and subsequent dispatch by the President of the Governing Council to the Chair of the Commission on Sustainable Development.

- 4. The following sentence should be added at the end of paragraph 16 of Annex III: "The consideration by the Committee of the Whole on items 5(a) and (b) on special themes will be in a dialogue format with the discussions being introduced by selected panelists and resource persons."
- 5. As indicated in Annex IV which contains the time-table for the schedule of meetings for the Governing Council, agenda item 9 on the UN-HABITAT Work Programme and Budget is scheduled to be considered by the Committee of the Whole on Wednesday, 6 April, during the morning and afternoon sessions. Arrangements will, however, be made, in consultations with the Bureau of the Governing Council for the establishment of an informal Working Group on this item, which would begin its work on Tuesday, 5 April.
- 6. In paragraph 8 of Annex III the title of the second dialogue with local authorities and other Habitat Agenda Partners should read "Financing Shelter and Urban Development" and not "Strengthening the United Nations Habitat and Human Settlements Foundation (Item 8 of the provisional agenda). The same correction should be made in Annex IV with respect to the dialogue indicated for plenary in the afternoon of Wednesday 6 April 2005.
- 7. Paragraphs 11 of Annex VI should be deleted and replaced with the following Paragraph:
 - "An advanced draft of the Global Report on Human Settlements 2005, provisionally entitled "Financing Shelter and Urban Development" will be distributed to delegates and a summary of the main findings of the report will also be made available to the twentieth session of the Governing Council."
