- Policy on decentralized water supply scheme

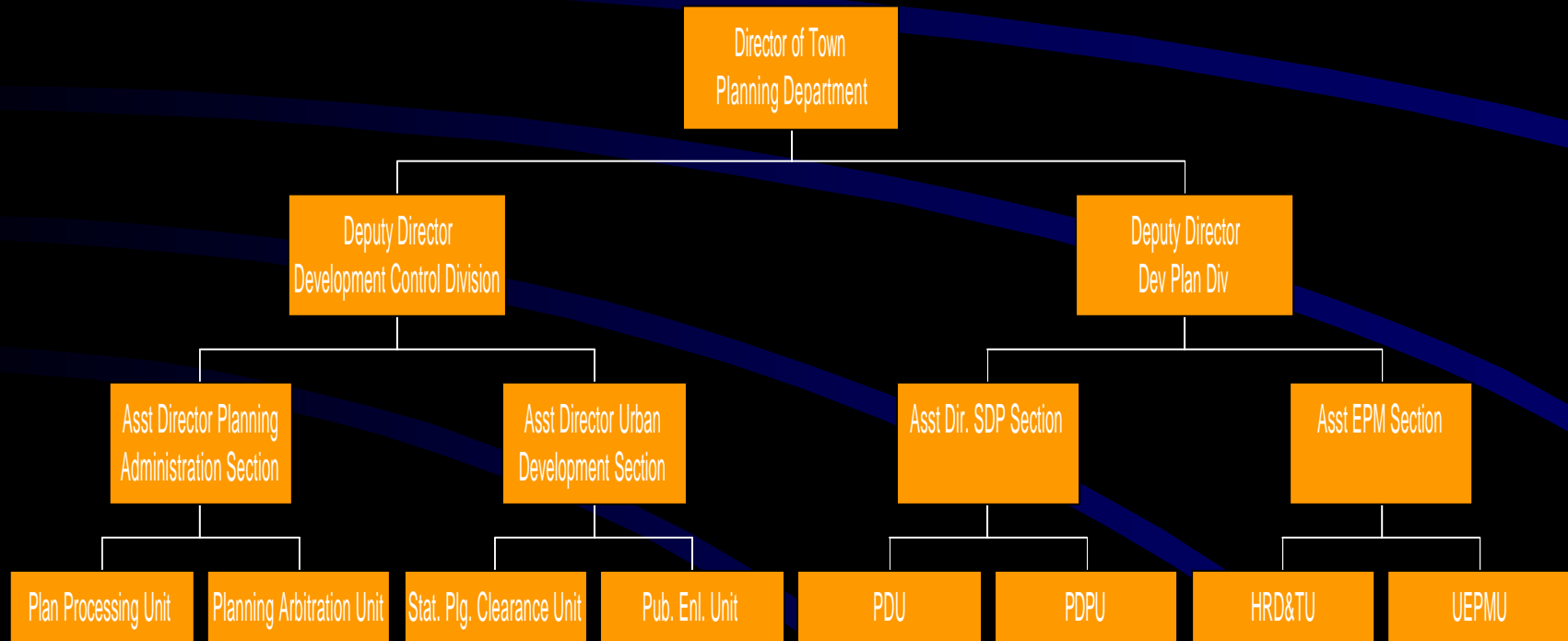
